Failure to provide the requested information and documents as required may lead to problems in the full and qualified execution of the investigations to be carried out by our Company in accordance with your request. In this case, our Company reserves its legal rights. For this reason, it is necessary to submit the relevant form in accordance with the nature of your request and in complete form, to include the requested information and documents therein.
